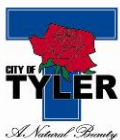
WHAT DO I NEED TO DO TO PERFORM AT ART WALK?

- ♦ Submit a completed application packet by mail or hand-delivery to 110 W. Erwin, Tyler, TX 75702
- ♦ Application must include:
 - A non-refundable \$10 entry fee payable by cash, check or money order. No credit cards, please.
 - A completed **Description/Info page** and **Waiver of Liability**. Both forms can be found below.
 - A compact disc containing a demo of artist's material.

An artist can submit *one (1) 60 second MP3* of their best work for committee review. If a performer does not have a video or MP3 of their work the following must be submitted instead: one digital publicity photo, a digital copy of a current letter of professional reference (6 months to 1 year old), and a digital copy of their performing history. Please utilize comment section of application for any explanation to the committee.

Based on this submission and available space the committee will accept the artist for Art Walk. MP3 files must be labeled with artist name and type of the performance, (example John Smith – Guitarist). **The digital file must be in MP3 format no more than 4MB in total.** Artists must mail or hand-deliver the compact disk with MP3 file(s) to Gallery Main Street, 110 W. Erwin, Tyler, TX 75702. Any submission mailed but received after the deadline will be ineligible for exhibition. The attached **Application and Waiver of Liability** and **Description/Info Pages**, along with the \$10 entry fee, must accompany the submission whether mailed or hand delivered.

Once an artist is accepted into the Art Walk, they will be notified via email, and a signed and dated **Application and Waiver of Liability** and **Description/Info Page** must be on file for participation. No artist will be allowed to perform during ArtWalk without a signed **Application and Waiver of Liability** on file. **All insurance and liability for performance is the responsibility of the artist.** All performing artists must register through DTAC (Downtown Tyler Arts Coalition). Committee-Approved Artists will be paired with a location on the Art Walk. Downtown parking meters are free after 4 p.m. There are numerous parking locations located around downtown. A map of downtown parking lots can be provided upon request.



Please complete the following Description and Information Pages, and the attached **Application and Waiver of Liability**, return by email, mail or hand-delivery to Gallery Main Street no later than Feb. 24, 2012. Anyone performing with you is required to complete the **Application and Waiver of Liability**, failure to do so will make them ineligible to participate in the Art Walk.

Performance space will be allocated at the discretion of the DTAC Art Walk committee.

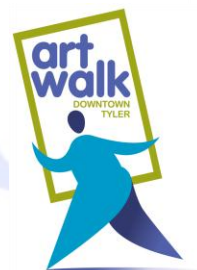
No Set-up is permitted prior to 1:00 p.m. March 15, 2012 without committee approval.

All storage considerations are the Performers Responsibility.

Performers are permitted to sell official copies of their work. Collection of all local and state sales taxes are the Performers responsibility.

Performers will provide **all** equipment necessary and appropriate for the space assigned. This includes but is not limited to: staging, dance floors, floor covering, P.A., sound systems, lighting, tables, or chairs. Electricity is available upon request, and is on a first-come, first-served basis.

Performers are permitted to place tip jars, open cases, etc at their location for donations. This will be monitored by the committee.

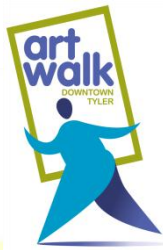

WAIVER OF LIABILITY

THAT FOR AND IN CONSIDERATION of being permitted to participate as a performer in activities associated with, but not limited to, the *Downtown Tyler Art Walk on March 15, 2012*, I and the **CITY** agree as follows:

I AGREE TO INDEMNIFY, RELEASE, FOREVER DISCHARGE, AND HOLD HARMLESS AND DEFEND THE CITY, INCLUDING GALLERY MAIN STREET, ITS DIRECTORS, OFFICERS, AGENTS AND EMPLOYEES, AND THE OWNERS, LESSEES, AND RESIDENTS WHOSE PREMISES ARE INVOLVED IN THE DOWNTOWN TYLER ART WALK, AND ALL OF THEIR REPRESENTATIVES, VOLUNTEERS, VISTORS, PARTICIPANTS, HEIRS, AND ASSIGNS (COLLECTIVELY ALL REFERRED TO AS "THE PARTIES") FROM ANY LOSS, DAMAGE OR INJURY, INCLUDING DEATH, RESULTING FROM PARTICIPATION OF ABOVE ENTRY IN THIS EVENT.

HOWEVER, NOTHING IN THIS AGREEMENT SHALL BE CONSTRUED AS OBLIGATING ARTIST TO INDEMNIFY "THE PARTIES" FOR THE NEGLIGENCE OR ACTIONS OF "THE PARTIES" WHOM ARTIST HAS NO RIGHT OF CONTROL.

THE ARTIST'S INDEMNIFICATION OBLIGATION PROVIDED HEREIN SHALL SURVIVE THE EXPIRATION OR TERMINATION OF THIS AGREEMENT.

I give permission to the City of Tyler and Gallery Main Street to reproduce loaned works for promotional materials for the purpose of promoting the works of art and Art Walk, so long as, in each instance, the Artist is credited as the creator of the work(s) and the holder of the copyright. Such promotion of the work(s) and Art Walk may include, but not be limited to, posters, flyers, prospectuses, postcards, invitations, e-mails and web-site postings.

RULES AND REGULATIONS FOR ARTISTS

Please note that this is an art event, with only the commercial focus being individual sale by the artist of their original art. Kits, imports, mass-produced items (this does not include CD's or DVD's of artists' performance), books, soaps, oils, antiques and other extraneous items are not allowed and may not be part of the artist's exhibit of approved art. All performers are subject to committee inspection and approval. Art Walk is a family-friendly event. Material containing explicit language, violence, or anything of a questionable nature should not be displayed or performed. All decisions are at the discretion of the Art Walk committee, and the City of Tyler and I consent to enforcement of all rules relating to Downtown Tyler Art Walk.
